- dissolves scales, cement, concrete deposits and corrosion
- low foaming and neutrally in fragrance
- not including hydrochloride acids - and complex builders

#### APPLICATION RANGE:

For descaling of all acid resistant materials and surfaces. Descaling of larger equipment, coffee machines, boilers, hot water makers, swimming pools, stainless steel surfaces and tiles (always observe instructions of producers)! **Not** suitable for use on enamel surfaces and coatings.

#### INSTRUCTIONS FOR USE AND DOSAGE:

**Application for descaling of equipment/machines:** Dilution 100 ml descaler per 1 L water. Add water up to 2/3rd of the water container incl. descaler solution. Heat up unit. If necessary repeat this process for perfect results. **Important!** After each descaling procedure rinse equipment with plenty of fresh cold water.

**For use as cleaner for descaling surfaces or objects:** Wipe solution over surface (use above dosage) and allow to impact. Neutralize after each process with fresh cold water. Always follow instructions of producers - for surface cleaning and for descaling!
