The quality of the protective gloves resistant to chemicals must be chosen as a function of the specific working place concentration and quantity of hazardous substances. Breakthrough time (maximal wear duration): Wear duration with occasional contact, splashes (Level 2: < 30 min): Disposable-gloves, Thickness of the material 0,1mm.
