APPLICATION RANGE: Fast acting sanitary cleaner on basis of highly effective sulfamic acids. Removes reliably lime residues, soap lime, urine stone and lime-fat deposits. On all acid and water proof materials, surfaces and objects in the sanitary area - applicable on wall and floor tiles, sinks, wc-bowls, ceramic urinals, porcelain and stainless steel. **Not** applicable on acid sensitive surfaces.

INSTRUCTIONS FOR USE AND DOSAGE: **Daily cleaning:** Wet wiping in single or double stage technology - 20-80 ml on 8 L water (0.25-1 %). Strong soiling requires a higher dosage - up to 400 ml on 8 L cold water (up to 5 %). Allow a short penetration time - rinse off with clear water. Squeeze pure in WC bowls and urinals underneath. Allow a short penetration time - before cleaning entire bowl with brush. Flush after cleaning. **Surface cleaning:** Add Premium N° 1 Viscous pure onto cleaning cloth or sponge - clean surfaces. After a short penetration time - remove agents with clear cold water.

Conduct a material compatibility test on a small area before starting. Always follow the cleaning and maintenance instructions of suppliers of sanitary installations. If improperly applied - and for claims resulting from such improper handling - there will be no legal claims accepted.
